**Stop use and ask a doctor if ■** you experience any of the following signs of stomach bleeding

- feel faint vomit blood have bloody or black stools
- have stomach pain that does not get better

- an allergic reaction occurs. Seek medical help right away.
- pain lasts for more than 10 days or gets worse
- new symptoms occur
- redness or swelling is present
- ringing in the ears or a loss of hearing occurs

## If pregnant or breast-feeding
