##### **Directions for Dilutions:**

Add 1 gallon CONFIDENCE 1-10 to 3 gallons of water and agitate until thoroughly mixed. Proper dilution of CONFIDENCE 1-10 will yield a 1% iodine teat dip sanitizer with 10% emollients.
