For external anal and genital itching adults:

- gently dry by patting or blotting with toilet tissue or soft cloth before applying
- product may be applied to the skin of the anal canal with a clean finger
- apply to affected area not more than 3 to 4 times daily
- Children under 12 years of age consult a doctor


