Ketotifen (0.025%)

Purpose

Antihistamine

(equivalent to ketotifen fumarate 0.035%)

Uses

Temporarily relieves itchy eyes due to pollen, ragweed, grass, animal hair and dander.

Warnings

Do not use

- if solution changes color or becomes cloudy
- if you are sensitive to any ingredient in this product
- to treat contact lens related irritation

When using this product

- do not touch tip of container to any surface to avoid contamination
- remove contact lenses before use
- wait at least 10 minutes before reinserting contact lenses after use
- replace cap after each use

Stop use and ask a doctor if you experience any of the following:

- eye pain
- changes in vision
- redness of the eye
- itching worsens or lasts more than 72 hours

Keep out of reach of children.

If swallowed, get medical help or contact a Poison Control Center right away.

Directions

- **Adults and children 3 years of age and older:** Put 1 drop in the affected eye(s) twice daily, every 8 to 12 hours, no more than twice per day.
- **Children under 3 years of age:** Consult a doctor.

- only for use in the eye
- store at 20° to 25°C (68° to 77°F) [see USP Controlled Room Temperature].

Inactive ingredients

Benzalkonium Chloride 0.01 %, Glycerin, Purified Water. May contain Hydrochloric Acid and/or Sodium Hydroxide to adjust pH.

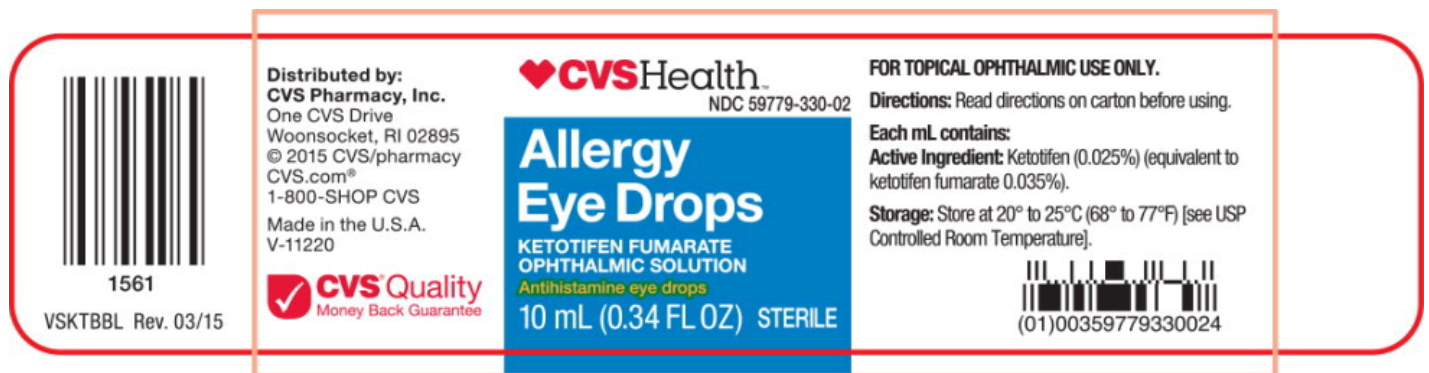
