Warnings

For external use only

- cough that occurs with too much phlegm (mucus)
- chronic cough that lasts or occurs with smoking, asthma, or emphysema

When using this product

- **do not heat, microwave, or add to hot water or any container where heating water. May cause splattering and result in burns.**
- do not take by mouth or place in nostrils
- do not get into eyes
- do not apply to wounds or damaged skin
- do not bandage tightly

Stop use and ask a doctor if

- cough lasts more than 7 days, comes back, or occurs with fever, rash, or headache

that lasts. These could be signs of a serious condition.

- muscle aches and pains worsen, persist for more than 7 days, or clear up and occur again within a few days
