adults and children 6 years and over - allow 2 drops to dissolve slowly in mouth, one at a time. May be repeated every 2 hours as necessary or as directed by a doctor.

children under 6 years - ask a doctor

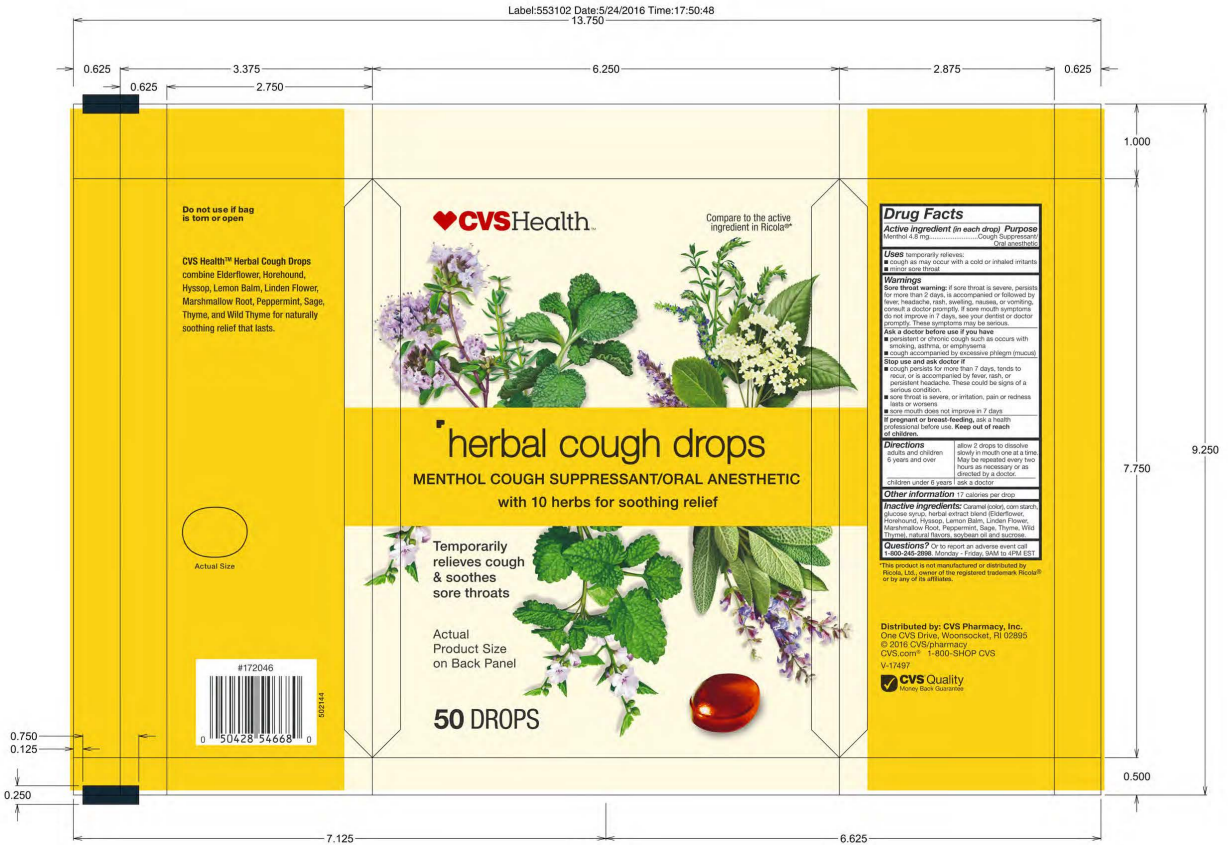

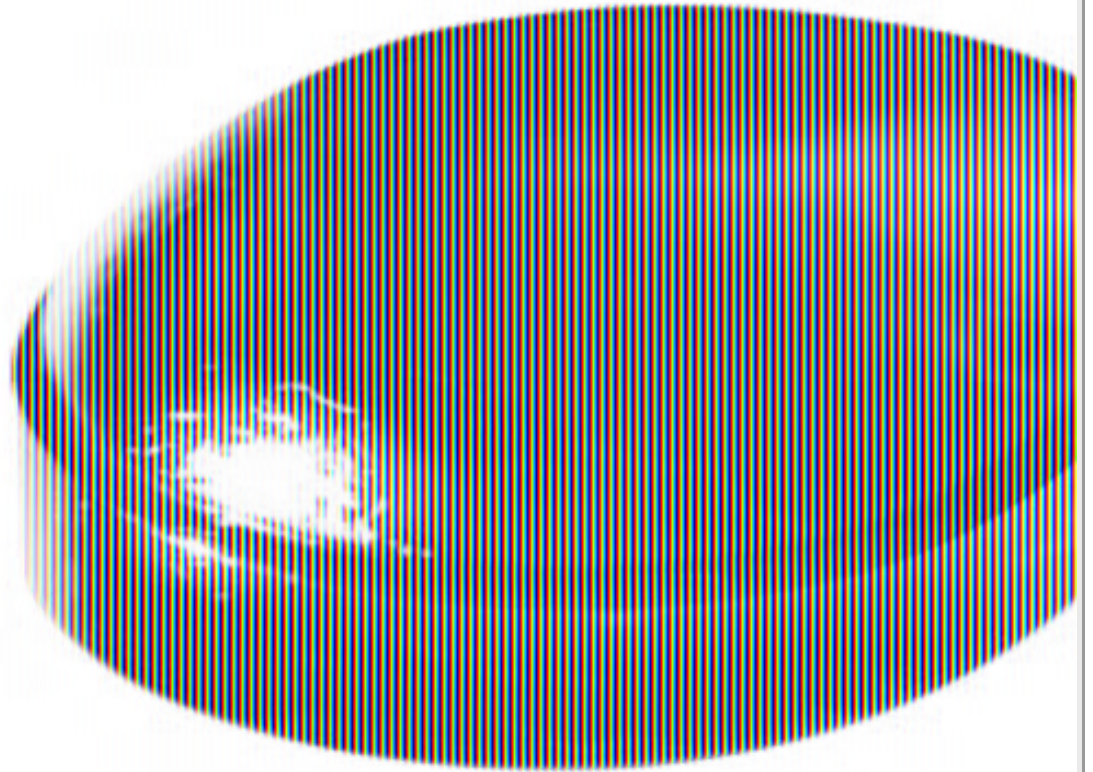
