Do not use patches for longer than five consecutive days,

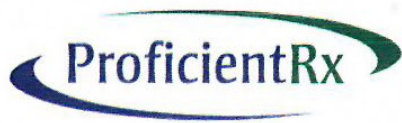
Children under 12 should consult physician prior to use.
