**Active ingredient (in each capsule)**

Loperamide HCl 2 mg

**Purpose**

Anti-diarrheal

**Use**

controls symptoms of diarrhea, including Travelers' Diarrhea

**Warnings**

**Allergy alert:** Do not use if you have ever had a rash or other allergic reaction to loperamide HCl

**Heart alert:** Taking more than directed can cause serious heart problems or death

**Do not use**

- if you have bloody or black stool
- in children under 12 years of age

**Ask a doctor before use if you have**

- fever
- mucus in the stool
- a history of liver disease
- a history of abnormal heart rhythm

**Ask a doctor or pharmacist before use if you are**

taking a prescription drug. Loperamide may interact with certain prescription drugs

**When using this product**

tiredness, drowsiness, or dizziness may occur. Be careful when driving or operating machinery.

**Stop use and ask a doctor if**

- symptoms get worse
- diarrhea lasts for more than 2 days
- you get abdominal swelling or bulging. These may be signs of a serious condition.

**If pregnant or breast-feeding,**

ask a health professional before use.

**Keep out of reach of children.**

In case of overdose, get medical help or contact a Poison Control Center right away.

***Directions***

- **drink plenty of clear fluids to help prevent dehydration caused by diarrhea.**
- **not for use in children under 12 years of age**
- adults and children 12 years and over: 2 capsules after the first loose stool; 1 capsule after each subsequent loose stool; but no more than 4 capsules in 24 hours

***Other information***

- store at 20°-25°C (68°-77°F). Protect from light.
- avoid excessive heat above 40°C (104°F).
- do not use if carton or blister unit is open or torn
- see side panel for lot number and expiration date

***Inactive ingredients***

butylated hydroxyanisole, edible ink, FD&C Blue #1 , gelatin, glycerin, glyceryl caprylate, polyoxyl 40 hydrogenated castor oil, purified water
