- condition clears up and recurs within a few days

- clean the affected area
- apply to the area not more than 3 to 4 times daily
- children under 2 years of age: consult a doctor

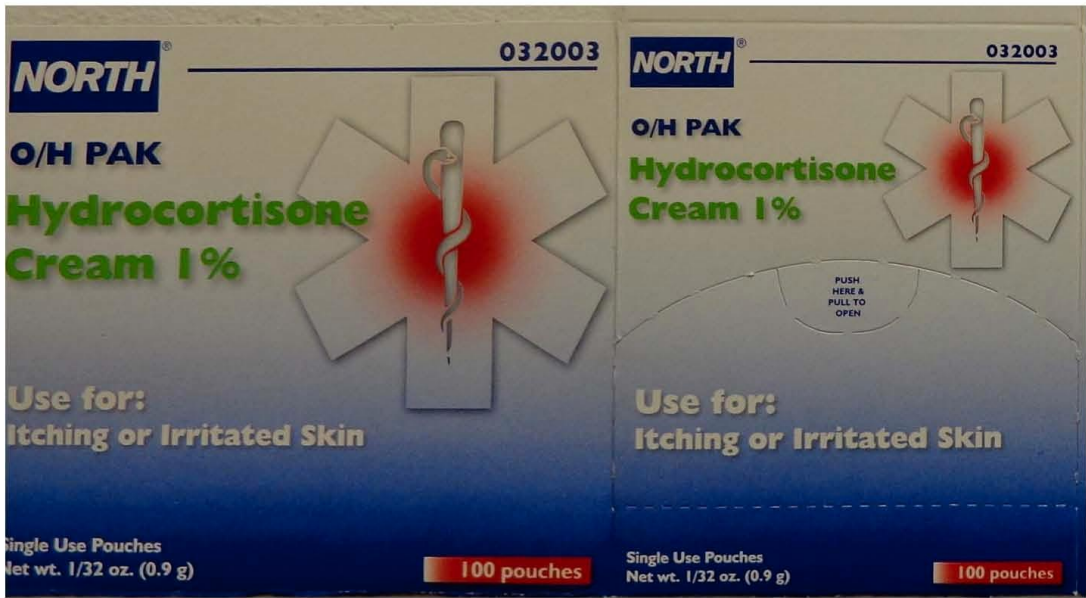
