**Purpose**

Lubricant laxative

**Use**

for relief of occasional constipation (irregularity). Generally produces bowel movement in 6 to 8 hours.

**Do not use**

- if you have difficulty swallowing
- in children under 6 years of age
- if you are pregnant
- for a period longer than week
- if you are bedridden or aged

**Ask a doctor before use if you have**

- abdominal pain, nausea, or vomiting
- noticed a sudden change in bowel habits that persists over a period of 2 weeks

**Ask a doctor or pharmacist before use if you are**

- presently taking a stool softener laxative
- taking any other drug. Take this product 2 or more hours before or after othr drugs. Laxatives may affect how other drugs work.

**When using this product**

do not take with meals. Take only at bedtime.

**Stop use ad ask a doctor**

if you have rectal bleeding or failure to have a bowel movement after use. These could be signs of a serious condition.

**If breast feeding,**

ask a health professional before use.

**Keep out of reach of children.**

in case of overdose, get medical help or contact a Poison Control Center right away.

**Directions**

- do not take with meals
- take only at bedtime
- may be taken as a single daily dose or in divided doses

adults and children 12 years of age and over - 1 to 3 Tablespoons (15 - 45 mL)  
maximum 3 Tablespoons (45 mL) in 24 hours

children 6 to under 12 years of age - 1 to 3 teaspoons (5 - 15 mL) maximum 3  
teaspoons (15 mL) in 24 hours

children under 6 years of age - do not use, consult a doctor

**Other information**

keep tightly closed. Protect from sunlight.

mixed tocopherols (added as a stabilizer)
