Active ingredient (in each enteric coated tablet)

Bisacodyl USP 5 mg

Purpose

Stimulant laxative

Use

- for relief of occasional constipation (irregularity)
- this product generally produces bowel movement in 6 to 12 hours

Warnings

Do not use

in children under 6 years of age

Ask a doctor before use if you have

- abdominal pain
- nausea
- vomiting
- noticed a sudden change in bowel habits that persists over a period of 2 weeks

Ask a doctor or pharmacist before use if you are

unable to swallow without chewing

When using this product

- do not chew or crush tablets
- do not take this product within 1 hour after taking an antacid or milk
- abdominal discomfort, faintness, and cramps may occur

Stop use and ask a doctor if

- you need to use more than 1 week
- rectal bleeding or failure to have a bowel movement occurs after use of a laxative. These may be signs of serious condition.

If pregnant or breast-feeding,

ask a health professional before use.

Keep out of reach of children

In case of overdose, get medical help or contact a Poison Control Center right away.

Directions

- each tablet works differently. Adults and children over 12 may need fewer tablets to get the same effect as more tablets of another brand
- start with one tablet and take with water. If one tablet does not produce the desired results, then try two or three tablets daily.
- do not take more than 3 tablets daily

adults and children 12 years of age and older	take 1 to 3 tablets in a single dose once daily
children 6 to under 12 years of age	take 1 tablet once daily
children under 6 years of age	Ask a doctor

Other information

- **each tablet contains:** calcium 15 mg
- store at 15° - 30° C (59°- 86° F)
- keep in a dry place
