Acetaminophen 160 mg

***Purpose***

Pain reliever/fever reducer

***Uses***

- temporarily relieves minor aches and pains due to:
  - the common cold
  - flu
  - headache
  - sore throat
  - toothache
  
- temporarily reduces fever

***Warnings***

**Liver warning:** This product contains acetaminophen. Severe liver damage may occur if your child takes:

- more than 5 doses in 24 hours, which is the maximum daily amount
- with other drugs containing acetaminophen

**Allergy Alert:** acetaminophen may cause severe skin reactions. Symptoms may include:

- skin reddening
- blister
- rash

If a skin reaction occurs, stop use and seek medical help right away

**Sore throat warning:** If sore throat is severe, persists for more than 2 days is accompanied or followed by fever headache, rash, nausea or vomiting, consult a doctor promptly.

**Do not use**

- with any other drug containing acetaminophen (prescription or nonprescription). If you are not sure whether a drug contains acetaminophen, ask a doctor or pharmacist.
- if your child is allergic to acetaminophen or any of the inactive ingredients in this product.

**Ask a doctor before use if your child has**

liver disease.

**Ask a doctor or pharmacist before use if your child is**

taking the blood thinning drug warfarin.

**When using this product**

**do not exceed recommended dose (see overdose warning).**

**Stop use and ask a doctor if**

- pain gets worse or lasts more than 5 days
- fever gets worse or lasts more than 3 days
- new symptoms occur
- redness or swelling is present

These could be signs of a serious condition.

**Keep out of reach of children.**

**Overdose warning:** In case of overdose, get medical help or contact a Poison Control Center right away at 1-800-222-1222. Quick medical attention is critical even if you do not notice any signs or symptoms.

**Directions**

- **this product does not contain directions or complete warnings for adult use.**
- **do not give more than directed (see overdose warning)**
- **chew or crush tablets completely before swallowing**
- find the right dose on chart below. If possible, use weight to dose; otherwise use age.
- repeat dose every 4 hours while symptoms last
- do not give more than 5 times in 24 hours
