Purpose

Pain reliever/fever reducer

Uses

temporarily relieves

- headache • muscle pain • toothache
- menstrual pain • pain and fever of colds • minor pain of arthritis

Warnings

Reye's syndrome: Children and teenagers who have or are recovering from chicken pox or flu-like symptoms should not use this product. When using this product, if changes in behavior with nausea and vomiting occur, consult a doctor because these symptoms could be an early sign of Reye's syndrome, a rare but serious illness.

Allergy Alert: Aspirin may cause a severe allergic reaction which may include:

- hives • facial swelling • asthma (wheezing) • shock

Stomach bleeding warning: This product contains an NSAID, which may cause severe stomach bleeding. The chance is higher if you

- are age 60 or older
- have had stomach ulcers or bleeding problems
- take a blood thinning (anticoagulant) or steroid drug
- take other drugs containing prescription or nonprescription NSAIDs (aspirin, ibuprofen, naproxen, or others)
- have 3 or more alcoholic drinks every day while using this product
- take more or for a longer time than directed

Do not use

if you are allergic to aspirin or any other pain reliever/fever reducer

Ask a doctor before use if

- stomach bleeding warning applies to you
- you have a history of stomach problems, such as heartburn
- you have high blood pressure, heart disease, liver cirrhosis, or kidney disease

- you are taking a diuretic
- you have asthma

Ask a doctor or pharmacist before use if you are

taking a prescription drug for:

- gout • diabetes • arthritis

Stop use and ask a doctor if

- an allergic reaction occurs (seek medical help right away)
- you experience any of the following signs of stomach bleeding:
 - feel faint • vomit blood • have bloody or black stools • have stomach pain that does not get better
- pain gets worse or lasts more than 10 days
- redness or swelling is present
- fever lasts more than 3 days
- new symptoms occur
- ringing in the ears or a loss of hearing occurs

If pregnant or breast-feeding,

ask a health professional before use. **It is especially important not to use aspirin during the last 3 months of pregnancy unless definitely directed to do so by a doctor because it may cause problems in the unborn child or complications during delivery.**

Keep out of reach of children.

In case of overdose, get medical help or contact a Poison Control Center right away.

Directions

- drink a full glass of water with each dose
- adults and children 12 years and over: take 1 or 2 tablets every 4 hours or 3 tablets

every 6 hours, not to exceed 12 tablets in 24 hours

- children under 12 years: consult a doctor

Other information

- save carton for full directions and warnings
- store at room temperature
