**Purpose**

Lubricant laxative

**Use**

for relief of occasional constipation (irregularity). Generally produces bowel movement in 6 to 8 hours

- if you have difficulty swallowing
- in children under 6 years of age
- if you are pregnant
- for a period longer than week
- if you are bedridden or aged

**Ask a doctor before use if you have**

- abdominal pain, nausea, or vomiting
- noticed a sudden change in bowel habits that persists over a period of 2 weeks

**Ask a doctor or pharmacist before use if you are**

- presently taking a stool softener laxative
- taking any other drug. Take this product 2 or more hours before or after other drugs. Laxatives may affect how other drugs work.

**When using this product**

do not take with meals. Take only at bedtime.

**Stop use and ask a doctor**

if you have rectal bleeding or failure to have a bowel movement after use. These could be signs of a serious condition.

**If breast feeding,**

ask a health professional before use

**Keep out of reach of children**

- may be taken as a single daily dose or in divided doses

teaspoons (15 mL) in 24 hours

children under 6 years of age - do not use, consult a doctor
