Active ingredient (in each drop)

Menthol 7.6 mg

Purpose

Antitussive (cough suppressant)/oral anesthetic

Uses

Temporarily relieves

- cough as may occur with a cold or inhaled irritants
- occasional minor irritation and sore throat

Warnings

Sore throat warning:

If sore throat is severe, persists for more than 2 days, is accompanied or followed by fever, headache, rash, nausea, or vomiting, consult a doctor promptly. These symptoms may be serious.

Ask a doctor before use if you have

- persistent or chronic cough such as occurs with smoking, asthma, or emphysema
- cough accompanied by excessive phlegm (mucus)

Stop use and ask a doctor if

- cough persists for more than 1 week, tends to recur, or is accompanied by fever, rash, or persistent

headache.

These could be signs of a serious condition.

- sore mouth does not improve in 7 days
- irritation, pain, or redness persists or worsens

If pregnant or breast-feeding, ask a health professional before use.

Keep this and all drugs out of the reach of children.

Directions

- **do not use more than directed**

**Adults and children:
(12 years and older)**

Allow 1 drop to dissolve slowly in the mouth. May be repeated every 2 hours as necessary or as directed by a doctor.

Children under 12 years:

ask a doctor

- store at 59-86°F (15°-30°C)
- protect from moisture & heat
