- children under 12 years of age: ask a doctor

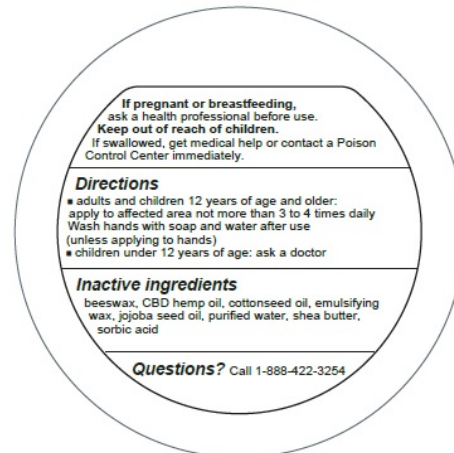
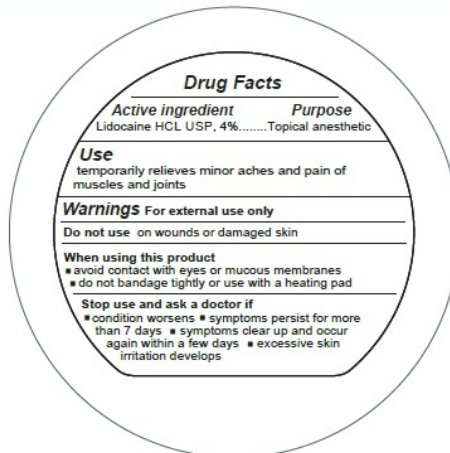
