Diphenhydramine HCl 25 mg

***Purpose***

nighttime sleep-aid

***Uses***

- for the relief of occasional sleeplessness
- reduces time to fall asleep if you have difficulty falling asleep

***Warnings***

**Do not use**

- for children under 12 years of age
- with any other product containing diphenhydramine, even one used on skin.

**Ask a doctor before use if you have**

- a breathing problem such as asthma, emphysema, or chronic bronchitis
- glaucoma
- difficulty in urination due to enlargement of the prostate gland
- heart disease

**Ask a doctor or pharmacist before use if you are** taking sedatives, tranquilizers or any other sleep aid

**When using this product**

- avoid alcoholic beverages and other drugs that cause drowsiness
- drowsiness will occur
- be careful when driving a motor vehicle or operating machinery

**Stop use and ask a doctor if** sleeplessness persists continuously for more than 2 weeks. Insomnia may be a symptom of serious underlying medical illness.

**If pregnant or breast-feeding,** ask a health professional before use.

**Keep out of reach of children.** Overdose warning: Taking more than directed can cause serious health problems. In case of overdose, get medical help or contact a Poison Control Center right away. 1(800)222-1222

- take only one dose per day (24 hours) - see Overdose warning

adults & children 12 yrs & over	One dose= TWO 25 mg capsules(50 mg) at bed time if needed or as directed by a doctor
children under 12 years	Do not use

- store at 20-25°C (68-77°F)
- avoid excessive heat above 40°C (104°F) and high humidity
- Protect from light
