ACTIVE INGREDIENT

Iodine Complex 36%

Isopropyl Alcohol 40%

Indications and Directions

Usage:

A topical antiseptic for use on cattle, horses, swine and sheep to reduce the risk of infection and cross infection of superficial cuts and abrasions.

Directions:

Cleanse affected area thoroughly with mild soap and water. Apply 7% Iodine lightly to affected area not more than once daily. Do not use under a bandage as a burn may result. Prior to use on open skin, dilute 1 part 7% iodine with 3 parts water.

Caution

If redness, irritation or swelling persists or increases, discontinue use and consult a veterinarian. Avoid contact with eyes and mucous membranes. Do not use on burns, in body cavities or on deep or punctured wounds.
