Jock Itch, known medically as tinea cruris, is a common skin infection of the groin, buttocks and inner thigh caused by fungus. Signs and symptoms often include itching, scaling, and redness. In severe cases the skin may blister. Jock Itch fungus may infect any part of the middle of the body, but most often grows in the folds of the skin between the inner thighs and groin. The same fungus may also affect the nails, hands or feet. It is a member of the larger group of skin infections known as tinea. Tinea cruris is caused by a number of different fungi called dermatophytes. The condition is typically acquired by coming into contact with infected skin or clothing. Common places where the fungi can survive are around swimming pools and in locker rooms. Usually diagnosis is made based on signs and symptoms.

Some methods of prevention include keeping the infected area clean and dry, changing clothes every day and wearing loose fitting garments. When infected, the area should be kept dry. Treatment can be either with an antifungal medication like FUNGINIX AF which is applied to the skin such as tolnaftate or for persistent infections antifungal medication that are taken by mouth such as terbinafine. Use of any antifungal cream is typically recommended for a minimum of four weeks.
