Reapply after 80 minutes of swimming or sweating, after towel drying, or at least every 2 hours.

Exposure to sun increases risk of skin cancer and skin aging. To decrease risk, regularly use sunscreen with broad spectrum SPF 30 or higher and: limit time in the sun, especially from 10 am - 2 pm, wear long sleeve shirt, pants, hat and sunglasses. Children under 6 months, ask a doctor.
