For use as a supplemental nutritive source of vitamin B_{12} in cattle, horses, swine, sheep, dogs and cats.

DOSAGE AND ADMINISTRATION

Inject subcutaneously or intramuscularly. May be injected intravenously at the discretion of the veterinarian.

Cattle, Horses, Swine and **Sheep--**1 to 2 mL.

Dogs and **Cats**--0.25 to 0.5 mL.

Suggested dosage may be repeated at 1 to 2 week intervals, as indicated by condition and response.

Store at controlled room temperature between 15° to 30°C (59° - 86°F). Avoid exposure to light.
