Pain reliever/fever reducer

Uses

- temporarily relieves minor aches and pains due to:
 - headache

 - toothache
 - the common cold

Warnings

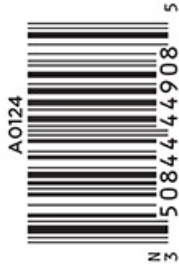
