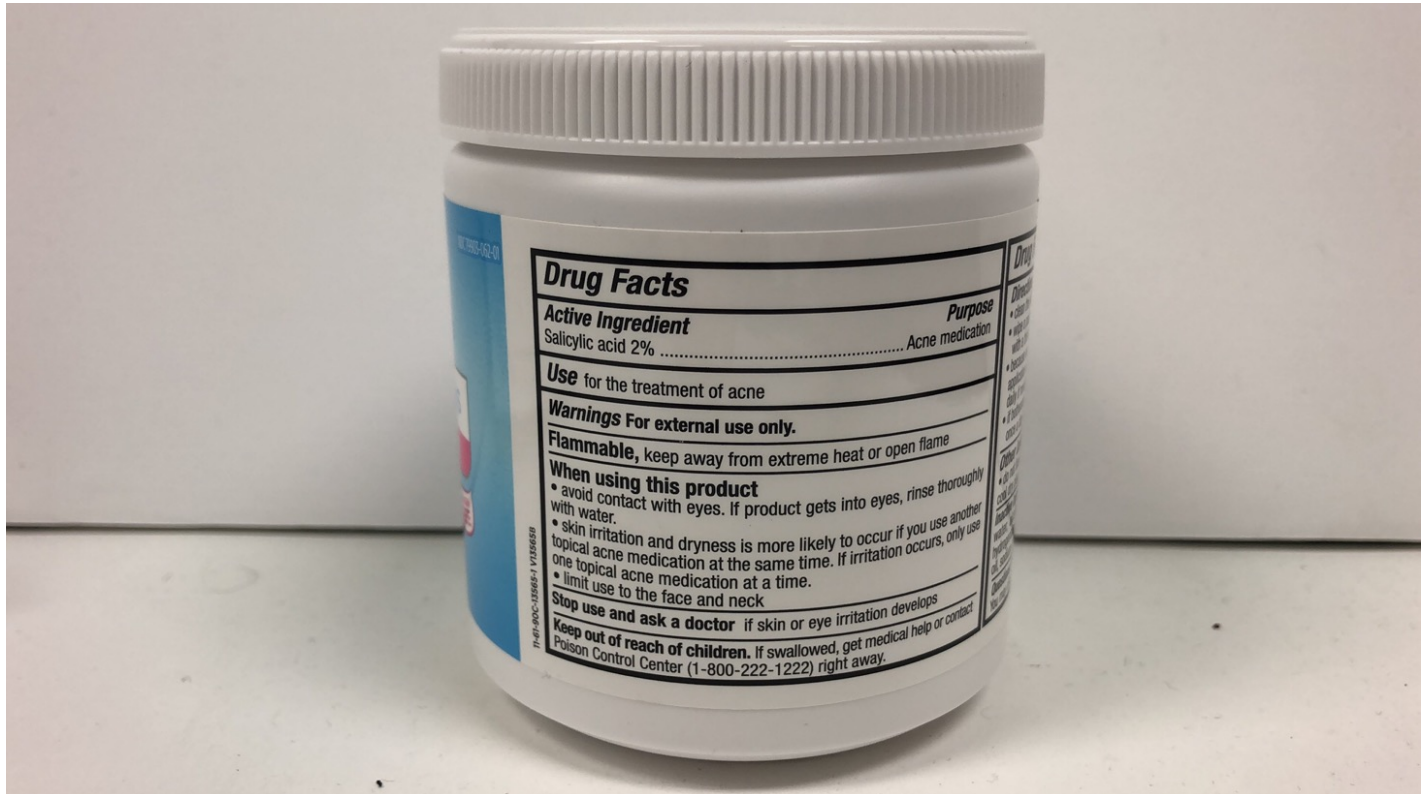

Acne medication

- avoid contact with the eyes. If product gets into the eyes rinse thoroughly with water.
- skin irritation and dryness is more likely to occur if you use another topical acne medication at the same time. If irritation occurs, only use one topical acne medication at a time.
- limit use to the face and neck

**Keep out of reach of children.** If swallowed, get medical help or contact Poison Control Center (1-800-222-1222) right away.

**Stop use and ask a doctor** if skin or eye irritation develops.

- do not flush in toilet
- keep jar lid tightly closed
- store in cool dry place
- do not freeze

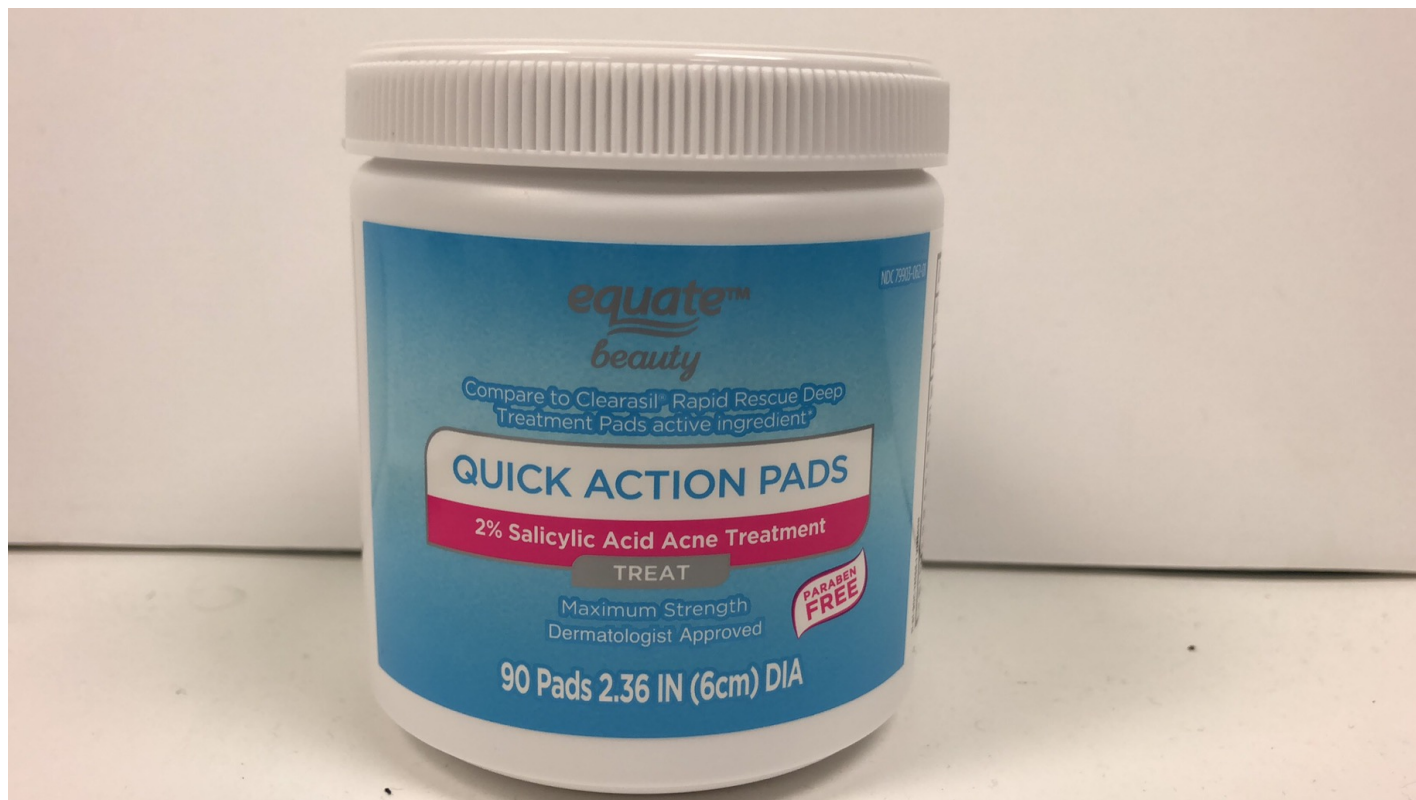

### Directions

- Clean the skin thoroughly before applying this product
- wipe a pad over the face and neck to cover the entire affected area with a thin layer one to three times daily
- because excessive drying of the skin may occur, start with one application daily, then gradually increase to two or three times daily if needed or as directed by a doctor.
- if bothersome dryness or peeling occurs, reduce application to once a day or every other day
