Antifungal

Uses

- cures most athlete's foot, jock itch, and ringworm
- relieves itching, burning, cracking, scaling and discomfort

Warnings

For external use only.

Avoid contact with eyes.

Do not use on children under 2 years of age unless directed by a doctor.

Stop use and ask a doctor if

- irritation occurs
- there is no improvement within 4 weeks for athlete's foot and ringworm or 2 weeks for jock itch

If pregnant or breast-feeding, ask a health professional before use.

Keep out of reach of children. If swallowed, get medical help or contact a Poison Control Center (1-800-222-1222) right away.

Directions

- wash affected area and dry thoroughly
- apply a thin layer over affected area twice daily (morning and night) or as directed by a doctor
- supervise children in use of this product
- for athlete's foot, pay special attention to spaces between the toes, wear well fitting, ventilated shoes and change shoes and socks at least once daily
- for athlete's foot and ringworm, use daily for 4 weeks; for jock itch, use daily for 2

weeks

- if condition persists longer, consult a doctor
- this product is not effective on scalp or nails

- store at 15 to 30°C (59 to 86°F)
- **Tamper Evident:** DO NOT USE IF SEAL ON TUBE IS PUNCTURED OR MISSING.
