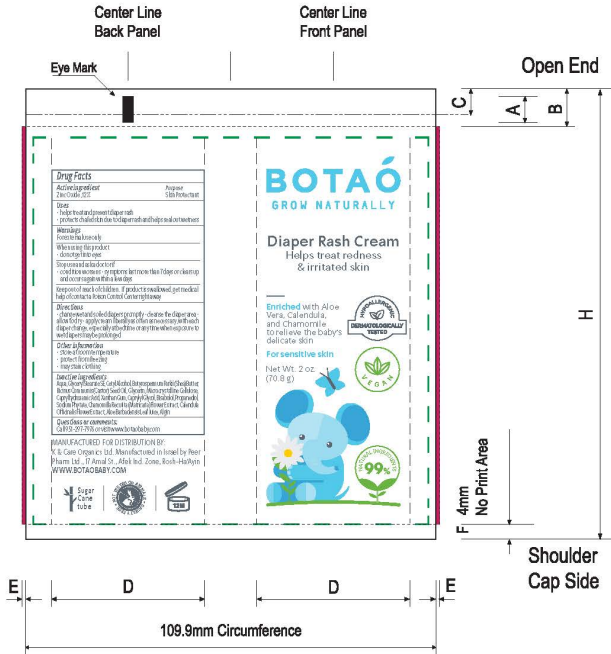

- E = **1mm bleed** for circumferential print. Overlap seam app. 1.5-2mm.
- F = **4mm no print area on the cap side**.

 8. Minimum negative text size 7-8pt (or, small letters like "e, a, o" = 1.2 mm high and line width 0.2 mm).
 9. Please make texts with spot colors @ 100%.
10. Positive line thickness = 0.15 mm.
 11. Negative line width = 0.2 mm.
12. Please adhere to unprinted areas in layout.
 13. Please keep sealing area noise free.
 14. Please specify Pantone colors (try to stick to spot colors). We will recommend otherwise if needed.
15. Minimum barcode size 80%, minimum bar length 10 mm - placed along the tube.

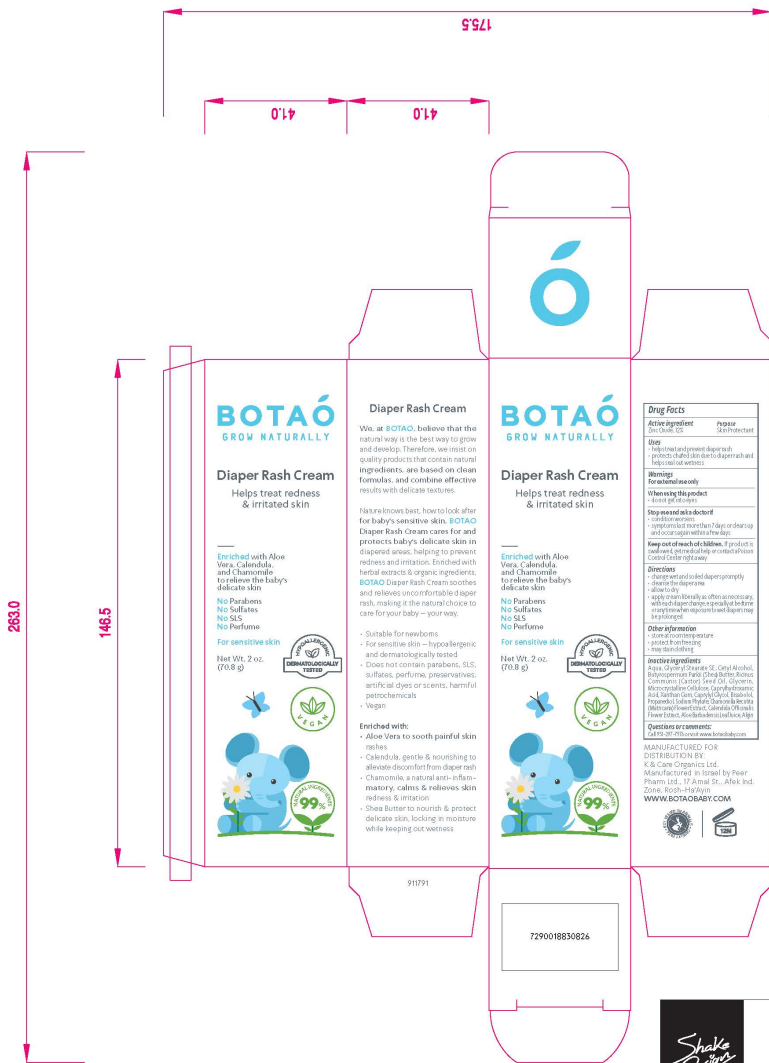
