- Just prior to milking, if udders are heavily soiled, wash entire udder thoroughly with **Gil Udder Wash**.
- Dry udder with a single-service towel to avoid milk contamination.
- Either spray teats with undiluted Gil Aloe Protect or fill teat cup with undiluted product.
- Dip each teat as far as possible into the teat cup.
- Wipe teat dry after dipping or spraying using a single-service towel to avoid contaminating milk.

POST-DIP:

- Immediately after milking, submerge entire teat in undiluted product.
- Allow to air dry—do NOT wipe.
- Do NOT let cows out in freezing weather until completely dry.

INHALATION: Supply fresh air. If irritation persists, get medical attention.
