warning: This product contains an NSAID, which may cause stomach bleeding. The chance is small but higher if you: ■ are age 60 or older ■ have stomach ulcers or bleeding problems ■ take a blood thinning (anticoagulant) or steroid drug ■ take other drugs containing an NSAID (aspirin, ibuprofen, naproxen, or others) ■ have 3 or more alcoholic drinks every day while using this product ■ take (apply) more or for longer time than directed

Do not use:

on the face or rashes ■ on wounds or damaged skin ■ if allergic to aspirin or other NSAIDs ■ with a heating pad ■ when sweating (such as from exercise or heat) ■ any patch from a pouch that has been open for 14 or more days ■ right before or after heart surgery

When using this product

■ use only as directed ■ wash hands after applying or removing patch ■ avoid contact with eyes, If eye contact occurs, rinse thoroughly with water ■ Dispose of used patch away from children and pets.

Used patches still contain the drug product which can produce serious adverse effects if a child or pet chews

or ingests the patch ■ the risk of heart attack or stroke may increase if you use more than directed or for longer than directed

Stop use and consult a doctor

■ stomach pain or upset gets worse or lasts ■ you feel faint, vomit blood, or have bloody or black stools. These are a sign of stomach bleeding ■ rash, itchy or skin irritation develops ■ condition worsens ■ symptoms last for more than 3 days ■ symptoms clear up and occur again within a few days

Keep out of reach of children

If swallowed, get medical help or contact a Poison Control Center (1-800-222-1222) right away. Packaging is not child-resistant

Uses

For temporary relief of minor aches and pains of muscles and joints associated with arthritis, simple backache, strains, sprains, and bruises.

Directions

Adults 18 years of age and over: ■ only use 1 patch at a time ■ clean and dry affected area.

■ remove patch from backing film and apply to skin (see illustration) ■ leave patch in place for up to 8 to 12 hours

■ if pain lasts after using the first patch, a second patch may be applied for up to another 8 to 12 hours ■ remove

used patch from the skin before a new one is applied ■ do not use more than 2 patches per day ■ do not use for more than 3 days in row ■ properly discard patch after single use ■ reseal pouch after opening.

Children under 18 years of age: do not use this product.

Hydrogenated Poly, Pentaerythrityl Tetra-di-t-butyl Hydroxyhydrocinnamate, Petroleum, Styrene / Isoprene Copolymer

Indication and Usage

Temporarily relieves mild to moderate aches and pains of muscles and joints associated with:

■ strains ■ sprains ■ simple backache ■ arthritis ■ bruises

If pregnant or breastfeeding
