#### **Purpose**

Anti-itch

#### **Uses**

- temporarily relieves itching associated with minor skin irritations, inflammation, and rashes due to:
- eczema
- psoriasis
- poison ivy, oak, sumac
- insect bites
- detergents
- jewelry
- cosmetics
- soaps
- seborrheic dermatitis
- temporarily relieves external anal and genital itching
- other uses of this product should only be under the advice and supervision of a doctor

#### **Warnings**

##### **For external use only**

##### **Do not use**

- for the treatment of diaper rash. Ask a doctor.
- in the genital area if you have a vaginal discharge. Ask a doctor.

##### **When using this product**

- avoid contact with the eyes
- do not use more than directed unless told to do so by a doctor
- do not put directly into the rectum by using fingers or any mechanical device or applicator

##### **Stop use and ask a doctor if**

- condition worsens, symptoms persist for more than 7 days or clear up and occur again within a

few days, and do not begin use of any other hydrocortisone product unless you have asked a doctor

### **Directions**

- **for itching of skin irritation, inflammation, and rashes:**
- adults and children 2 years of age and older: apply to affected area not more than 3 to 4 times daily
- children under 2 years of age: do not use, ask a doctor
- **for external anal and genital itching, adults:**
- when practical, clean the affected area with mild soap and warm water and rinse thoroughly
- gently dry by patting or blotting with toilet tissue or a soft cloth before applying
- apply to affected area not more than 3 to 4 times daily
- children under 12 years of age: ask a doctor

- store at 20°-25°C (68°-77°F)
